

GUIDANCE NOTES & CONDITIONS – EXPRESSIONS OF INTEREST

VICTUALLING YARD, 36 ROSIA ROAD, GIBRALTAR

- 1. Expressions of Interest (EOI) are invited for the conversion, fitting out and use of the existing first floor of the Victualling Yard for commercial purposes compatible with the nature of the building. Special attention needs to be paid to Health & Safety, Environmental & Heritage factors. Any scheme will require approval by the Development and Planning Commission and obtain all necessary permits and licences.
- 2. The applicant shall be required to complete and submit (together with their proposal) an EOI Cover Sheet, which shall specify the premium sum offered to Her Majesty's Government of Gibraltar (HMGoG).
- 3. As part of their EOI, the applicant shall submit details of the design and specification of the proposal and any other detail(s) that may assist HMGOG in determining their preferred proposal.
- 4. The successful applicant will be granted licence and authority to enter the site for the purpose of carrying out surveys and investigations in preparing the required Planning / Building Application.
- 5. All costs in respect of the works required to convert and fit out the Victualling Yard to meet current Building, Environmental and Health & Safety standards will be to the account of the successful applicant.

- 6. The cost of connection and bringing services to the Victualling Yard shall be met by the successful applicant who shall been deemed to have carried out all necessary investigations and costings in submitting its EOI.
- 7. The applicant shall provide an approximation of its estimated cost of the conversion / fit-out works and all associated works. It will also provide with its submission, evidence of its financial capability to carry out and complete the proposal and to pay the premium sum offered. It will also have to confirm the source of such funds.
- 8. None of the ground floor units are available as part of this EOI. There is an existing lift connecting the ground floor to the first floor, which will be obsolete. There is currently no access to view the state and condition of the lift mechanism nor the lift shaft, however this space is included in the EOI for future use as a lift by the successful applicant should this be workable.
- 9. No parking facilities will be made available to the successful applicant.
- 10. The applicant shall be deemed to have visited the premises and carried out all necessary surveys investigations and inspections and have collected all information required for its submission. There may be asbestos present in materials, finishes or components. The applicant will be required to carry out its own surveys and comply with current legislation and regulations dealing with asbestos and hazardous materials/substances.
- 11. The applicant shall provide details of previous experience, if any, involving similar projects.

- 12. The applicant shall be considered to have become familiar with all laws and regulations that may affect activities on the site.
- 13. HMGoG shall not be responsible nor pay any expense or loss which may be incurred by an applicant in the preparation of any EOI submission.
- 14. The applicant shall, whether they have inspected the Victualling Yard or not, be deemed to have submitted an EOI with full knowledge of the actual state and condition of the Victualling Yard in all respects including the position of all boundaries and no irregularity or discrepancy in relation thereto shall invalidate its EOI or be made the subject of a claim for compensation.
- 15. The information provided in these Guidance Notes and Conditions is not guaranteed with respect of accuracy, currency, exhaustiveness or completeness and HMGoG accepts no responsibility for the information or interpretations placed on the EOIs submitted by applicants. Applicants should submit their EOI based on their own investigations and determinations.
- 16. In the case of individuals, Directors or Partners, applicants will be required to give consent to the Royal Gibraltar Police (RGP) to release details of any convictions, if the RGP are requested to do so by HMGoG or any authorised company or agency.
- 17. On completion of the works to convert the chambers to the satisfaction of HMGoG, HMGoG will grant a full repairing and insuring lease for a term to be determined, having regard to the scale of the proposals submitted.
- 18. Expressions of Interest with all accompanying documents and plans clearly marked "VICTUALLING YARD EXPRESSIONS OF INTEREST" shall be submitted sealed and addressed to HM Government of Gibraltar and deposited in the Expressions of Interest
